

INCLUSIVE POST-SECONDARY EDUCATION (IPSE)



IPSE gives students with intellectual disabilities the opportunity to attend college with their peers who may or may not have a disability. They participate in the same classes, same clubs, same residences, and same athletics as students who may not have an intellectual disability.

NATIONALLY, STUDENTS EXITING AN IPSE PROGRAM ARE FIVE TIMES MORE LIKELY TO BE EMPLOYED COMPARED TO ADULTS SERVED BY THEIR STATE'S I/DD AGENCIES ALONE

and 1.6 times more likely to be employed compared to adults with independent living disabilities receiving support from their VR Agencies alone.



ADVOCACY AT THE CAPITOL THIS YEAR

While IPSE Grants cover tuition costs, the current allocation does not fully fund the scholarships to include mandatory IPSE-specific fees that students must pay along with tuition. IPSE program fees are not typical campus or student fees, but additional costs that provide the necessary staff & resources to support IPSE students.

GEORGIA CURRENTLY ALLOCATES \$955,830 FOR IPSE GRANTS (SCHOLARSHIPS) THROUGH THE GEORGIA STUDENT FINANCE COMMISSION. THESE FUNDS COVER TUITION AT PUBLIC UNIVERSITIES AND TECHNICAL COLLEGES.

THIS YEAR WE'RE ADVOCATING FOR AN ADDITIONAL \$1,644,170 IN THE GEORGIA STUDENT FINANCE COMMISSION'S BUDGET FOR IPSE GRANTS TO FULLY FUND TUITION AND REQUIRED IPSE PROGRAM FEES FOR OUR STUDENTS. TO ACHIEVE THIS GOAL, WE'RE ADVOCATING FOR \$2.6 MILLION IN TOTAL IPSE GRANTS.
