## Directions to the GAO

Our address is One West Court Square, Suite 625, Decatur, GA 30030, but this address is not found on GPS. The best way to find our parking deck, which is right next to our building, is to look for the Emory Clinic at **158 W. Ponce de Leon Ave., Decatur, GA 30030**. The entrance to our deck is found to the left of the Emory Clinic and is marked by a standing sign near the street that says "Public Parking." You'll see a big mural in shades of blue. Enter the deck there.

The first level of the deck is for two-hour and accessible parking only. If you plan to stay longer than two hours, and you do not need an accessible parking space, do not park on the first level or your vehicle may be towed. Bring your parking stub with you, and we'll validate it for you. Please be aware that the deck does not have an elevator.

Our building – the **DeVry Building** – is next to the parking deck (it's the blue/gray building to the left of the Emory Clinic). There are two entrances to the building. The first entrance is found when you exit the deck and has stairs. **The accessible entrance is around the building on the opposite side.** When you enter the building, take the elevator to **Suite 625**.

## From the Decatur MARTA Station

Exit the station using the gate closest to the elevator. This is the <u>bus-loop</u> side of the station. When you get outside, turn right and you will see our seven-story building. Follow the sidewalk and go through the opening in the black metal fence. Continue straight on the sidewalk until you see the front of the building, with "One West Court" written above the entrance. We are in **Suite 625**.
